

Sustainable Community Buildings Programme – Funding Factsheet
Supported by the Cumbria Waste Management Environment Trust and the Lake District National Park Sustainable Development Fund



Here is a (not exhaustive) list of funds to try for those considering energy efficient refurbishment or rebuild of their community buildings.

Local Funders

Sustainable Community Buildings Programme

Advice, information and funding for energy efficiency and renewable measures in Cumbrian community buildings. Funding is subject to an energy audit of your building to ensure that energy efficiency is maximised.

£75,000 fund available through Cumbria Waste Management Environment Trust and the Lake District National Park Sustainable Development Fund.

Projects must be in the National Park, or within 10 miles of a landfill site (this is most of Cumbria so don't worry).

50% match up to £10,000. 75% match for costs of audit in LDNPA areas.

Copeland Community Fund

Grants for projects within Copeland Borough Council area, or that have significant benefit to the Copeland residents. Six themes including: Environment & Sustainability, Young people and Community and Improvements to Built Environment.

WREN (Waste Recycling Environmental)

Projects must be within ten miles of the landfill sites at Lillyhall, Workington and Bennet Bank, Barrow in Furness.

Small Grants – Projects must be applying for capital funding of between £2,000 and £15,000, with a total project cost of less than £50,000. Village Hall/Church Hall/Community Centre all eligible to apply.

Main Grant Fund - Projects must fulfil object D of the Landfill Communities Fund.

Object D – “The primary intent of the project must be to facilitate an improvement for the general public's benefit for leisure or recreational activity. The amenity site must be open and accessible for the general public. It should be somewhere where the general public can go, join or use without any limit or restrictions of use (or with reasonable access costs) being in place. Work must be targeted on a specific amenity at a single location.”

The EON Sustainable Energy Fund

Grants of up to £20,000 to community groups and not for profit organisations who wish to consider and implement sustainable energy projects in their buildings - from energy efficiency through to micro-generation. Can support applications from religious or political organisations if the community building that the technology or measures are to be installed into is available for the whole community to use regardless of religious or political beliefs. Benefits to the whole community must be clearly demonstrated in your application.

Scottish Power Green Energy Trust

The Scottish Power Green Energy Trust is an independent charity which helps community-based renewable energy projects get off the ground. All kinds of projects are considered, from solar panels for sheltered housing to wind turbines for schools, but all must have a strong community benefit as well as a wider educational element. The trust will award up to 50% of the renewable energy element of the project, subject to a maximum award of £25,000, with most successful applications receiving around £10,000.

Other

Feed in Tariffs

Individuals, local authorities, community groups and other organisations who install low carbon electricity generating technologies up to 5MW are eligible to receive Feed-in-Tariffs. The introduction of Feed-in-Tariffs aims to incentivise the installation of small scale, low carbon electricity generating technologies. Each installation will qualify for a payment for each kW they produce and a further payment for each kW exported to the grid.

Small-scale low-carbon electricity technologies eligible for FITs are:

- Wind;
- Solar photovoltaics (PV);
- Hydro;
- Anaerobic digestion; and
- Domestic scale microCHP (with a capacity of 2kW or less)

Renewable Heat Incentive

The Renewable Heat Incentive is a Government scheme that provides financial support to non-domestic renewable heat generators and producers of biomethane. Eligible equipment installed after 15 July 2009 will be supported under the RHI.

Technologies included in the scheme are:

- Biomass boilers (Including CHP biomass boilers.
- Solar Thermal
- Ground Source Heat Pumps
- Water Source Heat Pumps
- On-Site Biogas combustion
- Deep Geothermal
- Energy from Municipal Solid Waste
- Injection of biomethane into the grid
